### **Members Day and Annual General Meeting**

On AGM Day, 15th June, the Railway is once again throwing open its doors for members to see what goes on behind the scenes. Departments will show what they do so members can get an idea of just what makes the Railway work. The idea of the day is to hopefully encourage members to see what is going on at their Railway and show them where they can help, either by volunteering or by other contribution.

We've made a few changes to the format from last year's very successful event, particularly to give members more time to explore the railway before attending the AGM itself. The service will begin earlier than a normal Saturday (first departures 9.20 am from Sheffield Park, 10.15 am from East Grinstead) and still have plenty of time to look around. The meeting will take place in a marquee on the top car park at Sheffield Park, commencing at 4 pm. Afterwards, there will be a social event with food and drink available. Trains will leave for East Grinstead after the AGM at 6.45 pm and later at 9.00 pm so, if you chose to arrive by rail, you can get home afterwards.

### **Event Details**

At Sheffield Park, a highlight of the day will be the formal renaming of 34059 Sir Archibald Sinclair, planned to take place at 12.00. Throughout the day, we are expecting that all areas within the loco yard (running shed, works, Atlantic House and maintenance shed) will be open to view the progress being made on the various restorations and overhauls that are underway. Various loco owning groups will have stands and will be on hand to update you on their respective projects. On the station, Friends of Sheffield Park and the Museum Team will have displays and representatives too. We also hope to display restored Pullman Car No 54 for viewing.

At Horsted Keynes, there will be tours of the Carriage & Wagon works, where you can see the progress being made on a number of carriages as they continue their journey back to full operational service. \* The SR Coach Group will have a display and be on hand to discuss their work on our Maunsell and Bulleid coaches. The wagon group will also have a display and stand to show visitors the progress they are making. On Platform 1/2 of the station, the Infrastructure teams will be mounting a display to explain the work they are undertaking there and the 1305 (Thumper) team will have a stand where they will be on hand to explain how they are bringing this unit, currently located nearby, back to working order. At the south end of Platform 2 there will be a meeting point for the S&T Department, from where you will be able to review proposals for the new Sheffield Park Signal Box, study the layout for the final East Grinstead signalling and view a display of unusual signalling features.

At all our stations, staff will be happy to answer questions and, subject to operational requirements, show you how things work in their particular part of the Railway. It is also hoped that guided visits to some of the signal boxes will be

possible, subject to permission of the signalman.

Don't forget that a lot of the individual project and owning group will have sales stands as part of their displays so please do support them where you can.

We hope that even more of you will join us on our Society AGM day this year to enjoy everything the Bluebell has to offer. Do take the opportunity to join in a conversation with Society management about how to take the Railway forward for the future and hopefully find ways in which you can help the Railway on that journey.

On behalf of the Chairman, Roy Watts, we look forward to seeing you.

The member may specify how the proxy is to vote or allow the proxy to use their discretion. If any member appoints a proxy and then attends the meeting, the proxy vote will not be counted.

### Robert Simpson

The Bluebell must offer other attractions that keep the visitors' attention and create an atmosphere where they will return and also bring others as their visit has opened eyes and created a thirst for more knowledge about the railway. Visitors alone will not pay the bills, so other revenue streams must be encouraged so that the reputation of the railway continues to increase with commercial organisations. I want to play my part and would encourage others to join the future movement, standing still and looking backwards will not work. We need to embrace changes or the railway is doomed to failure.

# Minutes of the 2<sup>nd</sup> Annual General Meeting held on Saturday 3<sup>rd</sup> June 2023 at Horsted Keynes Station commencing at 2:15pm

**Apologies for absence** were received from Gordon Pettitt (President), Ian Watson (Treasurer) and 43 members

### 1. Welcome & Remembrance

The Chairman welcomed everyone to the 2<sup>nd</sup> Annual General Meeting and he hoped everyone had enjoyed the new format of the meeting with a combined Members Day. This had been a huge success and he thanked all those who had put on interesting demonstrations and tours of the work that went on behind the scenes. He knew from comments he had received during the day that it had been appreciated by Members and how much they had learnt. He announced that he had 112 unfettered proxy votes had been received and a further 15 with diverse instructions. Four of those were against the minutes and one opposed to the reappointment of Knill James. Before taking the first item on the Agenda, Members stood in silence to remember the 79 members who had died since the last AGM in May 2022. May they all rest in peace.

# 2. Minutes of the 1<sup>st</sup> Annual General Meeting held Saturday 28<sup>th</sup> May 2022

The minutes of the Annual General Meeting held were proposed for adoption and agreed. There were no matters arising.

# 3. Adoption of the Society accounts for the year ended 31st December 2022

Mr Watson spoke briefly about the accounts and proposed their adoption, Mr Bridle asked why there was no audit certificate and it was explained that the accounts had been agreed by the auditors, and said so in the text. The full certificate would be in the consolidated accounts which had not yet been completed as they were awaiting the Plc accounts. The Chairman explained that the Plc accounts had been delayed as it had taken some time to agree the numbers and he promised these would be circulated once they had been agreed, The Society accounts for 2022 were adopted.

# 4. Authorise the Trustees to re-appoint Knill James as Auditors and to fix their remuneration

The Chairman said the complex transactions between the three bodies needed auditors who had the depth of knowledge about the railway and understood the relationship. He proposed the re-appointment of Knill James as auditors and this was agreed by a large majority.

# 5. Special Resolution No 1: Amend Articles 18 (Trustees) & 23 (Disqualification and removal of Trustees)

The Chairman said that since the original notice of the AGM and the proposed amendment to Article 18 had been given in earlier in the year, there had been further developments and the Trustees now wished to remove all constraints on Trustees serving as Directors or Trust Governors should the need arise. As explained in the AGM Booklet, the Society found itself in a position where it needed to fill essential posts on the Plc Board but Article 18 prevented us from doing so. We had proposed a further amendment to that proposed for Article 18 proposed so give us the flexibility to fill posts should the need arise. There was some discussion on the background to the proposed changes but it was accepted the Society had to have the flexibility to respond to unexpected circumstances which threatened the operation of the Railway.

The proposed amendment to Article 18.6 in Resolution 1 was passed with a large majority and the subsequent amended Article 18 and consequent charge to Article 23 was also passed with a large majority, well in excess of the 75% majority required.

# 6. Special Resolution No 2: Amend Article 20 (Powers, Proceedings and Duties of Trustees)

The Secretary explained this was a correcting amendment as we had previously resolved in 2022 to reinstate the Membership and Finance roles as Trustees and thus they were superfluous in Article 20.6 and this had not been spotted at the time. He proposed the amendment which was passed by a large majority in excess of the 75% required.

### 8 Chairman's Report

In his report, the Chairman explained why the Plc accounts were not finalised and warned that they would show a substantial loss for 2022. He outlined some of changes that had taken place on the Plc since the Society, as majority shareholder, had intervened in the last quarter of 2022. The state of the Board's finances was such that costs had been severely cut and it was very unfortunate that we had to reduce the number of paid staff as part of the cost cutting activity. Steve Trigg had been appointed as Finance Director towards the end of 2022 and he had worked hard to identify the financial issues the railway faced. He made no apologies for the appearance of dinosaurs, farm animals and Bluey and Bingo on some weekends this year as these had produced significant spikes in revenue for very little cost and had helped to improve the fortunes of the Plc. Much more work was needed to control costs and expenditure, and to boost revenue before we were able to return the railway to profit. He asked for everyone's support in the difficult times ahead.

### 9. Bluebell Trust Report

In the absence of published Trust accounts, Mr Tyson outlined the projects the Trust had supported during the year, much of it thanks to the substantial legacies the Trust had received in recent years. These legacies had made a significant difference to the projects the Trust had been able to fund, particularly in loco and carriage and wagon. The Trust had also funded further track renewals, specifically at Vaux End where the P/Way had been able to gain a substantial volume of recovered and useable ballast.

### 10. Election Results

The Chairman was delighted that Roy Watts was now officially Vice Chairman and he was grateful to Roy Watts for stepping up to the role in November last year. This was greeted with applause. The Trustee election results were as follows:
